

HOUSE FLOOR AMENDMENT

1 Amend printed bill, page 12, after line 24 insert:

2 "SECTION 8. In Colorado Revised Statutes, **add** 24-33.5-120 as  
3 follows:

4 **24-33.5-120. Concealed carry permit training class**  
5 **reimbursement.** (1) (a) THE DEPARTMENT SHALL REIMBURSE A PERSON  
6 FOR THE REASONABLE COSTS OF COMPLETING A CONCEALED HANDGUN  
7 TRAINING CLASS OR A CONCEALED HANDGUN REFRESHER CLASS THAT  
8 MEETS THE REQUIREMENTS SET FORTH IN SECTION 18-12-202.5. THE  
9 DEPARTMENT SHALL REIMBURSE A PERSON FOR ALL REASONABLE COSTS  
10 INCURRED BY THE PERSON ASSOCIATED WITH COMPLETING THE CLASS,  
11 INCLUDING TUITION, RANGE FEES, FIREARM RENTAL, AND AMMUNITION  
12 COSTS.

13 (b) THE MAXIMUM AMOUNT OF REIMBURSEMENT PURSUANT TO  
14 THIS SUBSECTION (1) IS TWO HUNDRED FIFTY DOLLARS PER CLASS. A  
15 PERSON MAY RECEIVE REIMBURSEMENT FOR ONE CLASS PER YEAR.

16 (2) THE DEPARTMENT SHALL DEVELOP A PROCESS FOR A PERSON  
17 TO APPLY FOR AND RECEIVE REIMBURSEMENT PURSUANT TO THIS SECTION.

18 **SECTION 9.** In Colorado Revised Statutes, **add** 24-33.5-121 as  
19 follows:

20 **24-33.5-121. Payment for attending concealed carry permit**  
21 **training class.** (1) THE DEPARTMENT SHALL PAY A PERSON FIFTY  
22 DOLLARS PER DAY FOR UP TO TWO DAYS PER YEAR THAT THE PERSON  
23 ATTENDS A CONCEALED HANDGUN TRAINING CLASS OR A CONCEALED  
24 HANDGUN REFRESHER CLASS THAT MEETS THE REQUIREMENTS SET FORTH  
25 IN SECTION 18-12-202.5.

26 (2) THE DEPARTMENT SHALL DEVELOP A PROCESS FOR A PERSON  
27 TO APPLY FOR AND RECEIVE PAYMENT PURSUANT TO THIS SECTION."
