HOUSE FLOOR AMENDMENT

Second Reading

BY REPRESENTATIVE Bottoms

1 Amend reengrossed bill, page 4, line 4, strike "DUTIES;" and substitute
2 "DUTIES. THIS SUBSECTION (2)(c) DOES NOT APPLY TO SECURITY
3 PERSONNEL EMPLOYED OR RETAINED BY AN ELECTED OFFICIAL TO
4 PROTECT THE ELECTED OFFICIAL WHILE ENGAGED IN THE PERSON'S
5 OFFICIAL DUTIES AS SECURITY PERSONNEL."

6 Page 4, after line 26 insert:

7 "(a) "ELECTED OFFICIAL" MEANS ANY PERSON WHO IS SERVING IN
8 AN ELECTED POSITION IN THE STATE OF COLORADO AT ANY LEVEL OF
9 GOVERNMENT OTHER THAN A STATEWIDE CONSTITUTIONAL OFFICER, AS
10 DEFINED IN SECTION 24-33.5-216.7."

11 Reletter succeeding paragraphs accordingly.

12 Page 5, line 7, strike "and (3)(j)" and substitute "(3)(j), and (4)".

13 Page 7, after line 16 insert:

14 "(4) NOTWITHSTANDING ANY PROVISION OF SUBSECTION (3) OF
15 THIS SECTION TO THE CONTRARY, SECURITY PERSONNEL EMPLOYED OR
16 RETAINED BY AN ELECTED OFFICIAL, AS DEFINED IN SECTION 18-12-105.3,
17 TO PROTECT THE ELECTED OFFICIAL SHALL NOT CARRY A FIREARM AT A
18 LOCATION DESCRIBED IN THIS SECTION WHILE ENGAGED IN THE PERSON'S
19 OFFICIAL DUTIES AS SECURITY PERSONNEL."

20 Page 7, lines 18 and 19, strike "(3)(c) introductory portion, and (3)(c)(I)"
21 and substitute "and (3)(c)".

22 Page 8, after line 23, insert:

23 "(IV) SUBSECTION (3)(c)(II) OF THIS SECTION DOES NOT APPLY TO
24 SECURITY PERSONNEL EMPLOYED OR RETAINED BY AN ELECTED OFFICIAL,
25 AS DEFINED IN SECTION 18-12-105.3, TO PROTECT THE ELECTED OFFICIAL
26 WHILE ENGAGED IN THE PERSON'S OFFICIAL DUTIES AS SECURITY
27 PERSONNEL."
