17	Sec. 2. The Firearms Control Regulations Act of 1975, effective September 24, 1976
18	(D.C. Law 1-85; D.C. Official Code § 7-2501.01 et seq.), is amended by adding a new section
19	1013 to read as follows:
20	"Sec. 1013. Extreme risk protection order implementation working group.
21	"(a) There is established an Extreme Risk Protection Order Implementation Working
22	Group ("Working Group"), which shall be composed of the following:
23	"(1) District government members, or their designees:
24	"(A) The Chairperson of the Council's Committee on the Judiciary and
25	Public Safety;
26	"(B) The Deputy Mayor for Public Safety and Justice;
27	"(C) The Deputy Mayor for Health and Human Services;

28		"(D) The Attorney General for the District of Columbia;
29		"(E) The Chief of the Metropolitan Police Department;
30		"(F) The Executive Director of the Office of Neighborhood Safety and
31	Engagement;	
32		"(G) The Director of the Department of Youth Rehabilitation Services;
33		"(H) The Chief Medical Examiner;
34		"(I) The Director of the Department of Forensic Sciences;
35		"(J) The Director of the Office of Victim Services and Justice Grants;
36		"(K) The Executive Director of the Criminal Justice Coordinating
37	Council; and	
38		"(L) The Director of the Department of Behavioral Health; and
39		"(2) Community members and organizations, or their designees:
40		"(A) Everytown for Gun Safety;
41		"(B) Moms Demand Action for Gun Sense in America, D.C. Chapter;
42		"(C) The Giffords Law Center to Prevent Gun Violence;
43		"(D) The Coalition to Stop Gun Violence;

47		"(H) The D.C. Behavioral Health Association; and

48	"(I) One representative from each of the District's violence interruption

51	"(b) The Working Group may also request the participation of other subject matter
52	experts, as well as designees of the following:
53	"(1) The Chief Judge of the Superior Court for the District of Columbia; and
54	"(2) The United States Attorney for the District of Columbia.
55	"(c) The Chairperson of the Council's Committee on the Judiciary and Public Safety and
56	the Deputy Mayor for Public Safety and Justice shall serve as the co-chairs of the Working
57	Group.
58	"(d) The duties of the Working Group shall include:
59	"(1) Improving public awareness of extreme risk protection orders;
50	"(2) Improving the coordination of District and federal agencies regarding the
51	filing, adjudication, and execution of extreme risk protection orders;
52	"(3) Facilitating the education of behavioral and mental health professionals about
53	extreme risk protection orders;
54	"(4) Advancing the development of District government policies and procedures
55	to govern extreme risk protection orders, such as written directives of the Metropolitan Police
56	Department; and
57	"(5) Reviewing and incorporating best practices from other jurisdictions
58	concerning extreme risk protection order laws, policies, and procedures.

59	"(e) The Working Group shall sunset on July 15, 2021.".

74	Sec. 4. Effective date.
75	(a) This act shall take effect following approval by the Mayor (or in the event of veto by
76	the Mayor, action by the Council to override the veto), a 30-day period of congressional review
77	as provided in section 602(c)(1) of the District of Columbia Home Rule Act, approved December
78	24, 1973 (87 Stat. 813; D.C. Official Code § 1-206.02(c)(1)), and publication in the District of
79	Columbia Register.
80	(b) This act shall expire after 225 days of its having taken effect.
