10	To amend, on a temporary basis, the Criminal Justice Coordinating Council for the District of
11	Columbia Establishment Act of 2011 to clarify the requirement that the CJCC report
12 13	aggregate programmatic data on process and outcomes of programs.
14	BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this
15	act may be cited as the "CJCC Data Collection Technical Correction Temporary Amendment
16	Act of 2023".
17	Sec. 2. Section 1501 of the Criminal Justice Coordinating Council for the District of
18	Columbia Establishment Act of 2011, effective October 3, 2001 (D.C. Law 14-28; D.C. Official
19	Code § 22-4234), is amended by adding new subsections (b-5) and (b-6) to read as follows:
20	"(b-5)(1) By December 1, 2023, and on a quarterly basis thereafter, the CJCC shall
21	submit to the Mayor and the Council and post on its website a report that includes the following
22	information, in accordance with existing law: Aggregate data on the following with respect to the
23	criminal justice and juvenile justice systems: diversion, pretrial supervision, detention,
24	prosecution, sentencing, commitment, incarceration, probation, parole, supervised release,
25	deferred prosecution agreements, deferred sentencing agreements, deferred disposition
26	agreements, and consent decrees.

27	"(2) The CJCC shall include in the report information and context to aid the
28	general public in interpretation of the data.
29	"(3) Prior to submitting and posting aggregate data, the CJCC shall provide each
30	agency that supplies data at least one week to review and comment on the data presentation and
31	any analysis relevant to the agency. The CJCC shall review the feedback provided by agencies
32	and determine, in its sole discretion, whether to revise the presentation and analysis accordingly.
33	"(b-6) The CJCC shall post the following year-to-date data on its website monthly,
34	beginning with the earliest year for which CJCC is able to obtain historical data:
35	"(1) Arrests for violent crimes committed by juveniles and adults, by offense; and
36	"(2) Gun violence and homicide counts and rates citywide and by ward,
37	neighborhood, and police service area.".
38	Sec. 3. Section 5 of the Prioritizing Public Safety Temporary Amendment Act of 2023,
39	passed on 2nd reading on September 19, 2023 (Enrolled version of Bill 25-396), is repealed.
40	Sec. 4. Fiscal impact statement.
41	The Council adopts the fiscal impact statement of the Budget Director as the fiscal impact
42	statement required by section 4a of the General Legislative Procedures Act of 1975, approved
43	October 16, 2006 (120 Stat. 2038; D.C. Official Code § 1-301.47a).
44	Sec. 5. Effective date.
45	(a) This act shall take effect following approval by the Mayor (or in the event of veto by
46	the Mayor, action by the Council to override the veto), a 60-day period of Congressional review
