AN ACT RELATING TO PROPERTY; AMENDING CHAPTER 1, TITLE 55, IDAHO CODE, BY THE AD-DITION OF A NEW SECTION 55-115, IDAHO CODE, TO DEFINE TERMS, TO PROVIDE THAT A HOMEOWNER'S ASSOCIATION MAY NOT IMPOSE FINES ON MEMBERS UNLESS ITS AUTHORITY TO DO SO IS CLEARLY SET FORTH IN THE COVENANTS AND RE-STRICTIONS; TO PROVIDE A PROCEDURE RELATING TO THE IMPOSITION OF FINES ON HOMEOWNER'S ASSOCIATION MEMBERS, TO PROVIDE THAT NO FINE SHALL BE IMPOSED IF A MEMBER BEGINS RESOLVING THE VIOLATION PRIOR TO THE MEETING SO LONG AS THE MEMBER CONTINUES TO ADDRESS THE VIOLATION IN GOOD FAITH 10 UNTIL FULLY RESOLVED, TO PROVIDE A RESTRICTION RELATING TO THE USE OF FINES AND TO PROVIDE THAT SPECIFIED LAW SHALL NOT AFFECT CERTAIN AUTHOR-11 ITY THAT MAY ALLOW FOR THE RECOVERY OF ATTORNEY'S FEES. 12 Be It Enacted by the Legislature of the State of Idaho: 13 14 SECTION 1. That Chapter 1, Title 55, Idaho Code, be, and the same is hereby amended by the addition thereto of a NEW SECTION, to be known and des-15 ignated as Section 55-115, Idaho Code, and to read as follows: 16 17 55-115. HOMEOWNER'S ASSOCIATION -- PROHIBITED CONDUCT. (1) As used in this section: 18 (a) "Homeowner's association" shall have the same meaning as in section 19 45-810(6), Idaho Code. 20 (b) "Board" means the entity that has the duty of governing the associ-21 ation that may be referred to as the board of directors, executive board 22 23 or any such similar name. (c) "Member" or "membership" means any person or entity owning or pos-24 sessing an interest in residential real property or lot within the phys-25 ical boundaries of an established homeowner's association. 26 (2) No fine may be imposed for a violation of the covenants and restric-27 tions pursuant to the rules or regulations of the homeowner's association 28 unless the authority to impose a fine is clearly set forth in the covenants 29 and restrictions and: 30 (a) A majority vote by the board shall be required prior to imposing any 31 fine on a member for a violation of any covenants and restrictions pur-32 suant to the rules and regulations of the homeowner's association. 33 (b) Written notice by personal service or certified mail of the meeting 34 during which such vote is to be taken shall be made to the member at least 35 36 thirty (30) days prior to the meeting. (c) In the event the member begins resolving the violation prior to the 37 meeting, no fine shall be imposed so long as the member continues to ad-38 dress the violation in good faith until fully resolved. 39 (d) No portion of any fine may be used to increase the remuneration of 40 any board member or agent of the board. 41

(e) No part of this section shall affect any statute, rule, covenant,
bylaw, provision or clause that may allow for the recovery of attorney's
fees.
