# HOUSE MOTION \_\_\_\_\_

MR. SPEAKER:

I move that House Bill 1369 be amended to read as follows:

- 1           Replace the effective dates in SECTIONS 1 through 27 with
- 2           "[EFFECTIVE JULY 1, 2021]".
- 3           Page 31, line 6, delete "must develop a process that allows" and
- 4           insert "**may develop recommendations for allowing**".
- 5           Page 31, between lines 15 and 16, begin a new line blocked left and
- 6           insert "**A recommendation under this subsection must be submitted**
- 7           **in an electronic format under IC 5-14-6 to the legislative council.**".
- 8           Page 34, between lines 7 and 8, begin a new paragraph and insert:
- 9           "SECTION 25. IC 35-47-11.1-4.1 IS ADDED TO THE INDIANA
- 10          CODE AS A NEW SECTION TO READ AS FOLLOWS
- 11          [EFFECTIVE JULY 1, 2021]: **Sec. 4.1. (a) As used in this section,**
- 12          **"department" means the Indiana department of natural resources.**
- 13          **(b) Any person not otherwise prohibited from carrying or**
- 14          **possessing a firearm under federal or state law shall be permitted**
- 15          **beginning September 1, 2021, to carry or possess, without**
- 16          **restriction, a firearm on any property:**
- 17                  **(1) affiliated with;**
- 18                  **(2) operated or managed by;**
- 19                  **(3) owned by; or**
- 20                  **(4) leased by;**
- 21          **the department.**

- 1           **(c) Before September 1, 2021, the department shall amend 312**
- 2 **IAC 8-2-3 to conform with subsection (b).**
- 3           **(d) A rule adopted by the department that conflicts with**
- 4 **subsection (b) after August 31, 2021, is void.**
- 5           **(e) The publisher of the Indiana Administrative Code and**
- 6 **Indiana Register shall amend 312 IAC 8-2-3 to reflect any change**
- 7 **made by the department under subsection (c).**
- 8           **(f) The department shall adopt emergency rules under**
- 9 **IC 4-22-2-37.1 to implement this section. An emergency rule**
- 10 **adopted by the department under this subsection expires on the**
- 11 **earlier of the following:**
- 12           **(1) The date the emergency rule is amended or repealed by a**
- 13 **later rule adopted under IC 4-22-2-24 through IC 4-22-2-36.**
- 14           **(2) September 2, 2022.**
- 15           **(g) The department shall adopt rules under IC 4-22-2 that**
- 16 **conform to subsection (b) not later than September 1, 2022."**
- 17           Renumber all SECTIONS consecutively.
