# HOUSE MOTION \_\_\_\_\_

MR. SPEAKER:

I move that House Bill 1369 be amended to read as follows:

- 1           Page 34, between lines 7 and 8, begin a new paragraph and insert:
- 2           "SECTION 24. IC 35-47-11.1-4.5 IS ADDED TO THE INDIANA
- 3           CODE AS A **NEW** SECTION TO READ AS FOLLOWS
- 4           [EFFECTIVE UPON PASSAGE]: **Sec. 4.5. (a) As used in this section,**
- 5           **"department" means the department of natural resources.**
- 6           **(b) As used in this section, "correctional facility" means any**
- 7           **building, structure, or improvement made or used for the custody,**
- 8           **care, confinement, or treatment of committed persons under IC 11.**
- 9           **(c) Except as provided in subsection (h), any person not**
- 10          **otherwise prohibited from carrying or possessing a firearm under**
- 11          **federal or state law shall be permitted beginning July 1, 2021, to**
- 12          **carry or possess, without restriction, a firearm on any property:**
- 13               **(1) affiliated with;**
- 14               **(2) operated or managed by;**
- 15               **(3) owned by; or**
- 16               **(4) leased by;**
- 17          **the department.**
- 18          **(d) Before July 1, 2021, the department shall amend 312**
- 19          **IAC 8-2-3 to conform with subsection (c).**
- 20          **(e) A rule adopted by the department that conflicts with**
- 21          **subsection (c) after June 30, 2021, is void.**
- 22          **(f) The publisher of the Indiana Administrative Code and**

- 1 **Indiana Register shall amend 312 IAC 8-2-3 to reflect any change**
- 2 **made by the department under subsection (d).**
- 3 **(g) The department shall adopt emergency rules under**
- 4 **IC 4-22-2-37.1 to implement this section. An emergency rule**
- 5 **adopted by the department under this subsection expires on the**
- 6 **earlier of the following:**
  - 7 **(1) The date the emergency rule is amended or repealed by a**
  - 8 **later rule adopted under IC 4-22-2-24 through IC 4-22-2-36.**
  - 9 **(2) July 1, 2022.**
- 10 **(h) A person may not possess a handgun at or on:**
  - 11 **(1) any reservoir owned by the U.S. Army Corps of Engineers;**
  - 12 **or**
  - 13 **(2) the property of the Falls of Ohio State Park.**
- 14 **(i) The department shall adopt rules under IC 4-22-2 that**
- 15 **conform to subsections (c) and (h) not later than July 1, 2022."**
- 16 **Page 38, after line 1, begin a new paragraph and insert:**
- 17 **"SECTION 29. An emergency is declared for this act."**
- 18 **Renumber all SECTIONS consecutively.**
