MR. SPEAKER:

I move that House Bill 1369 be amended to read as follows:

- 1 Replace the effective dates in SECTIONS 1 through 21 with
- 2 "[EFFECTIVE JULY 1, 2021]".
- 3 Replace the effective dates in SECTIONS 23 through 27 with
- 4 "[EFFECTIVE JULY 1, 2021]".
- 5 Page 30, delete lines 39 through 42.
- 6 Page 31, delete lines 1 through 21.
- 7 Page 34, between lines 7 and 8, begin a new paragraph and insert:
- 8 "SECTION 24. IC 35-47-11.1-4.1 IS ADDED TO THE INDIANA
- 9 CODE AS A **NEW SECTION TO READ AS FOLLOWS**
- 10 [EFFECTIVE UPON PASSAGE]: **Sec. 4.1. (a) As used in this section,**
- 11 **"department" means the Indiana department of natural resources.**
- 12 **(b) Any person not otherwise prohibited from carrying or**
- 13 **possessing a firearm under federal or state law shall be permitted**
- 14 **beginning July 1, 2021, to carry or possess, without restriction, a**
- 15 **firearm on any property:**
- 16 **(1) affiliated with;**
- 17 **(2) operated or managed by;**
- 18 **(3) owned by; or**
- 19 **(4) leased by;**
- 20 **the department.**
- 21 **(c) Before July 1, 2021, the department shall amend 312**
- 22 **IAC 8-2-3 to conform with subsection (b).**

- 1 **(d) A rule adopted by the department that conflicts with**
- 2 **subsection (b) after June 30, 2021, is void.**
- 3 **(e) The publisher of the Indiana Administrative Code and**
- 4 **Indiana Register shall amend 312 IAC 8-2-3 to reflect any change**
- 5 **made by the department under subsection (c).**
- 6 **(f) The department shall adopt emergency rules under**
- 7 **IC 4-22-2-37.1 to implement this section. An emergency rule**
- 8 **adopted by the department under this subsection expires on the**
- 9 **earlier of the following:**
- 10 **(1) The date the emergency rule is amended or repealed by a**
- 11 **later rule adopted under IC 4-22-2-24 through IC 4-22-2-36.**
- 12 **(2) July 2, 2022.**
- 13 **(g) The department shall adopt rules under IC 4-22-2 that**
- 14 **conform to subsection (b) not later than July 1, 2022."**
- 15 Page 38, after line 1, begin a new paragraph and insert:
- 16 "SECTION 28. **An emergency is declared for this act.**".
- 17 Re-number all SECTIONS consecutively.
