1 AN ACT concerning firearms; relating to the sale of firearms; amending
2 K.S.A. 2014 Supp. 12-16,124 and repealing the existing section.

4 *Be it enacted by the Legislature of the State of Kansas:*

5 Section 1. K.S.A. 2014 Supp. 12-16,124 is hereby amended to read as
6 follows: 12-16,124. (a) No city or county shall adopt or enforce any
7 ordinance, resolution or regulation, and no agent of any city or county
8 shall take any administrative action, governing **the requirement of fees,**
9 **licenses or permits for,** the *commerce in or the sale,* purchase, transfer,
10 ownership, storage, carrying ~~or,~~ transporting *or taxation* of firearms or
11 ammunition, or any component or combination thereof.

12 ~~(b) No city or county shall adopt or enforce any ordinance, resolution~~
13 ~~or regulation relating to the sale of a firearm by an individual, who holds a~~
14 ~~federal firearms license, that is more restrictive than any ordinance,~~
15 ~~resolution or regulation relating to the sale of any other commercial good.~~

16 ~~(e)~~ (b) Any ordinance, resolution or regulation prohibited by either
17 subsection (a) ~~or (b)~~ that was adopted prior to July 1, ~~2014~~ 2015, shall be
18 null and void.

19 ~~(d)~~ (c) Nothing in this section shall:

20 (1) Prohibit a city or county from adopting and enforcing any
21 ordinance, resolution or regulation relating to the personnel policies of
22 such city or county and the carrying of firearms by employees of such city
23 or county, except that any such ordinance, resolution or regulation shall
24 comply with the provisions of K.S.A. 2014 Supp. 75-7c01 et seq., and
25 amendments thereto;

26 (2) prohibit a city or county from adopting any ordinance, resolution
27 or regulation pursuant to K.S.A. 2014 Supp. 75-7c20, and amendments
28 thereto; ~~or~~

29 (3) prohibit a law enforcement officer, as defined in K.S.A. 22-2202,
30 and amendments thereto, from acting within the scope of such officer's
31 duties; **or**

32 **(4) prohibit a city or county from levying and collecting any**
33 **retailers' sales tax on the sale of firearms, ammunition or any**
34 **component or combination thereof as authorized by K.S.A. 12-189,**
35 **and amendments thereto.**

36 Sec. 2. K.S.A. 2014 Supp. 12-16,124 is hereby repealed.

1 Sec. 3. This act shall take effect and be in force from and after its
2 publication in the statute book.
