31 **committee room, if the officials are annually qualified in the use of firearms by**
32 **the Council on Peace Officer Standards and Training:**

33 **(a) The governor and a designated member of his staff.**

- 1 **(b) The lieutenant governor and a designated member of his staff.**
- 2 **(c) The secretary of state and a designated member of his staff.**
- 3 **(d) The treasurer and a designated member of his staff.**
- 4 **(e) The commissioner of agriculture and forestry and a designated**
- 5 **member of his staff.**
- 6 **(f) The commissioner of insurance and a designated member of his**
- 7 **staff."**
