### **An Act To Allow Municipalities To Prohibit Weapons at Municipal Public Proceedings and Voting Places**

1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. 25 MRSA §2011, sub-§3**, as enacted by PL 1989, c. 359, is amended to  
3 read:

4 **3. Exception.** This section does not prohibit an order, ordinance, rule or regulation  
5 of any political subdivision ~~which that~~, with the exception of appropriate civil penalty  
6 provisions, conforms exactly with any applicable provision of state law or ~~which that~~  
7 regulates the discharge of firearms within a jurisdiction or that regulates the carrying of  
8 firearms within a municipality in accordance with Title 30-A, section 3015.

9 **Sec. 2. 30-A MRSA §3015** is enacted to read:

10 **§3015. Regulation of weapons at municipal public proceedings and voting places**

11 Notwithstanding any other provision of law to the contrary, a municipality may adopt  
12 an ordinance that prohibits the carrying of a dangerous weapon at municipal public  
13 proceedings and voting places within the municipality. A municipal ordinance adopted  
14 pursuant to this section must provide an exception to allow the carrying of a handgun by  
15 an on-duty federal, state or local law enforcement officer. For the purposes of this  
16 section, "dangerous weapon" has the same meaning as in Title 17-A, section 2, subsection  
17 9, paragraph C, "law enforcement officer" has the same meaning as in Title 17-A, section  
18 2, subsection 17, "public proceeding" has the same meaning as in Title 1, section 402,  
19 subsection 2 and "voting place" has the same meaning as in Title 21-A, section 1,  
20 subsection 49.

21 **SUMMARY**

22 This bill allows municipalities to prohibit the carrying of dangerous weapons at  
23 municipal public proceedings and voting places within the municipality. It provides an  
24 exception to allow the carrying of a handgun by an on-duty law enforcement officer.
