AMENDMENTS TO HOUSE BILL 904  
(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 2, strike “Weapon-Free” and substitute “Gun-Free”; and in line 6, after “prohibition;” insert “establishing certain penalties;”.

AMENDMENT NO. 2

On page 2, in line 26, strike “OR”; after line 26, insert:

**“(7) AN EMPLOYEE OF AN ARMORED CAR COMPANY WHO IS:**

**(I) AUTHORIZED TO CARRY A FIREARM IN THE STATE IN THE REGULAR COURSE OF EMPLOYMENT; AND**

**(II) CARRYING OR POSSESSING A FIREARM ON THE PROPERTY OF A PUBLIC INSTITUTION OF HIGHER EDUCATION;**

**(8) THE AREA SURROUNDING A BUILDING OWNED OR OPERATED BY A PUBLIC INSTITUTION OF HIGHER EDUCATION FOR THE PURPOSE OF STUDENT HOUSING, TEACHING, RESEARCH, OR ADMINISTRATION, IF:**

**(I) THE AREA IS NOT LOCATED OTHERWISE ON A CAMPUS OF A PUBLIC INSTITUTION OF HIGHER EDUCATION; AND**

**(II) THE POSSESSION OF A FIREARM IN THE AREA IS NOT OTHERWISE PROHIBITED BY LAW; OR”;**

and in line 27, strike “(7)” and substitute “(9)”.

(Over)

On page 3, in line 1, strike “A” and substitute “EXCEPT AS PROVIDED IN PARAGRAPH (3) OF THIS SUBSECTION, A”; after line 2, insert:

“(3) A PERSON MAY NOT KNOWINGLY CARRY OR POSSESS A FIREARM ON THE PROPERTY OF A PUBLIC INSTITUTION OF HIGHER EDUCATION IF THE PERSON WAS PREVIOUSLY FOUND GUILTY OF A VIOLATION OF PARAGRAPH (2) OF THIS SUBSECTION.”;

in line 3, strike “paragraph” and substitute “PARAGRAPHS”; in the same line, after “(2)” insert “AND (3)”; in line 6, strike “A” and substitute “EXCEPT AS PROVIDED IN PARAGRAPH (3) OF THIS SUBSECTION, A”; and after line 7, insert:

“(3) (I) A VIOLATION OF SUBSECTION (B)(2) OF THIS SECTION IS A CIVIL OFFENSE PUNISHABLE BY A FINE OF \$2,500.

“(II) A PERSON WHO VIOLATES SUBSECTION (B)(3) OF THIS SECTION IS GUILTY OF A MISDEMEANOR AND ON CONVICTION IS SUBJECT TO IMPRISONMENT NOT EXCEEDING 18 MONTHS OR A FINE NOT EXCEEDING \$1,000 OR BOTH.”.
