BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, 12That the Laws of Maryland read as follows: 13 14 Article - Public Safety 15 5-306. 16 Subject to subsection (c) of this section, the Secretary shall issue a permit within a reasonable time to a person who the Secretary finds: 17 18 is an adult; (1) 19 (2)(i) has not been convicted of a felony or of a misdemeanor for which 20 a sentence of imprisonment for more than 1 year has been imposed; or 21 if convicted of a crime described in item (i) of this item, has been (ii) 22 pardoned or has been granted relief under 18 U.S.C. § 925(c);
