A BILL ENTITLED

1 AN ACT concerning

2 **Anne Arundel County – Turkey Hunting – Fall Season**

3 FOR the purpose of requiring the Department of Natural Resources to establish by
4 regulation a fall turkey season for certain portions of Anne Arundel County;
5 requiring the dates and bag limits for the fall turkey season established under
6 this Act to be consistent with the dates and bag limits established for the fall
7 turkey season in certain other counties; and generally relating to turkey
8 hunting in Anne Arundel County.

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
15 MARYLAND, That the Laws of Maryland read as follows:

16 **Article – Natural Resources**

17 10–405.

18 (a) (1) Pursuant to § 10–205 of this title, the Department shall establish
19 by regulation and publish by July 1 each year the open season to hunt forest and
20 upland game birds and mammals.

21 (2) Except as provided under § 10–410 of this subtitle, the Department
22 may not authorize hunting on a Sunday.

23 (3) (i) 1. Subject to subparagraph 2 of this subparagraph,
24 the Department shall establish by regulation by July 1 of each year a junior deer hunt

1 to occur on a Saturday and Sunday on the same weekend during a deer hunting
2 season.

3 2. The regulations adopted under this subparagraph
4 may not authorize the junior deer hunt to occur on a Sunday in a county in which deer
5 hunting is not authorized for that Sunday.

6 (ii) A person may participate in the junior deer hunt if the
7 person:

8 1. Is 16 years of age or younger;

9 2. Possesses a valid hunting license or is exempt from
10 hunting license requirements; and

11 3. Is accompanied by a person who:

12 A. Is at least 21 years of age;

13 B. Possesses a valid hunting license or is exempt from
14 hunting license requirements; and

15 C. Is not in possession of a firearm, a bow, or any other
16 hunting device.

17 (iii) A person who participates in the junior deer hunt may use a
18 firearm to hunt deer on the days of the hunt.

19 **(4) (I) THE DEPARTMENT SHALL ESTABLISH BY REGULATION**
20 **A FALL TURKEY SEASON FOR THE PORTION OF ANNE ARUNDEL COUNTY LYING**
21 **SOUTH OF MD ROUTE 214.**

22 **(II) THE DATES AND BAG LIMITS FOR THE FALL TURKEY**
23 **SEASON ESTABLISHED UNDER SUBPARAGRAPH (I) OF THIS PARAGRAPH SHALL**
24 **BE CONSISTENT WITH THE DATES AND BAG LIMITS ESTABLISHED FOR THE FALL**
25 **TURKEY SEASON IN ALLEGANY COUNTY, GARRETT COUNTY, AND WASHINGTON**
26 **COUNTY.**

27 (b) If the Department by regulation pursuant to § 10–205 of this title
28 restricts or reduces the number of days normally allowed to hunt, possess, sell,
29 purchase, ship, transport, carry, or export any game bird or mammal because of an
30 emergency situation, the Department may extend the open season to provide a
31 comparable number of days in any given season.

32 (c) The Department shall establish by regulation the maximum open season
33 for hunting crows which is permissible under federal law, and shall include in its

1 regulations such provisions as are permitted under federal law for control of crows at
2 any time they are found to be committing or about to commit depredation upon
3 ornamental or shade trees, agricultural crops, livestock or wildlife, or when
4 concentrated in such numbers and manner as to constitute a health hazard or other
5 nuisance.

6 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
7 July 1, 2014.
