- 3 FOR the purpose of establishing the Workgroup to Study Safe Harbor Policy for Youth 4 Victims of Human Trafficking; specifying the purpose of the Workgroup; providing for the composition, chair, and staffing of the Workgroup; prohibiting a member of 5 6 the Workgroup from receiving certain compensation, but authorizing the 7 reimbursement of certain expenses; establishing the duties of the Workgroup; 8 requiring the Workgroup to report its findings and recommendations to the Governor 9 and the General Assembly on or before a certain date; providing for the termination 10 of this Act; and generally relating to the Workgroup to Study Safe Harbor Policy for Youth Victims of Human Trafficking. 11
- 12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, 13 That:
- 14 (a) There is a Workgroup to Study Safe Harbor Policy for Youth Victims of Human 15 Trafficking.
- 16 (b) The purpose of the Workgroup is to study:
  - (1) legal protections for youth victims of human trafficking; and
  - (2) the provision of services for youth victims of human trafficking.
