General Provisions – Public Information Act – Enforcement, Fees, and Exemptions

FOR the purpose of altering certain provisions of law regarding the maintenance of public records relating to certain agricultural operations and programs; establishing the State Public Information Act Compliance Board; requiring the Governor to publish on the Governor's Office Web site certain notice relating to applications for membership on the Board and the names and qualifications of certain applicants; authorizing the Governor to broadcast certain interviews on the Governor's Office Web site; requiring the Governor, with the advice and consent of the Senate, to appoint the members of the Board from a certain pool of applicants; providing for the composition, chair, terms, and meetings of the Board; prohibiting a member of the Board from receiving certain compensation, but authorizing the reimbursement of certain expenses; requiring the Office of the Attorney General to provide staff for the Board; providing for the powers and duties of the Board; authorizing any person to file a certain complaint with the Board; requiring that the complaint contain certain information and be signed by the complainant; requiring the Board to take certain action regarding a complaint and filed within a certain time period; requiring a custodian who receives a complaint from the Board to file a certain response within a certain time period; requiring the Board to maintain the confidentiality of a certain public record; authorizing the Board, under certain circumstances, to hold a certain conference; providing that a certain conference held by the Board is not a contested case; requiring the Board to assess certain statutory damages and reimbursement of certain fees under certain circumstances; providing that compliance by a custodian with an order of the Board is not a certain admission and may not be used as evidence in a certain proceeding; providing that a complainant is not required to exhaust certain administrative remedies before seeking certain judicial review; repealing certain provisions of law related to the administrative review of a decision to deny inspection of a public record; requiring a person receiving benefits from the State to




