A BILL ENTITLED

1 AN ACT concerning

2 **Public Safety – Rifles and Shotguns – Transactions**

3 FOR the purpose of providing that a person who is not a certain licensee may not complete
4 the transfer of a certain rifle or shotgun in a certain role, except under certain
5 circumstances; requiring, before a certain transfer is conducted, the transferor and
6 transferee to meet jointly with a certain licensee and request that the licensee
7 facilitate the transfer; requiring a certain licensee to take certain actions when
8 facilitating a certain transfer; authorizing a certain transferor to remove a certain
9 rifle or shotgun from certain premises under certain circumstances; prohibiting a
10 certain licensee and transferor from completing a certain transfer if a certain
11 background check has a certain result; authorizing a certain transferor to remove a
12 certain rifle or shotgun from certain premises if a certain background check has a
13 certain result; authorizing a certain licensee to charge a reasonable fee for
14 facilitating a certain transfer; establishing certain penalties for violating this Act
15 and for providing false information while conducting a transfer under this Act;
16 excluding certain transfers from the scope of this Act; prohibiting a licensee or any
17 other person from selling, renting, or transferring a certain rifle or shotgun for a
18 certain period of time following the execution of a federal firearms transaction
19 record; requiring a person who sells, rents, or transfer a certain rifle or shotgun to
20 forward a certain written notification of the transaction to the Secretary of State
21 Police within a certain amount of time; requiring the Secretary to maintain a
22 permanent record of all notifications received in the State; prohibiting a person from
23 purchasing more than one certain rifle or shotgun in a 30–day period; providing for

1 certain exceptions to the prohibition on purchasing more than one certain rifle or
2 shotgun in a 30-day period; requiring a certain person who moves into the State to
3 register certain rifles and shotguns with the Secretary within a certain period of
4 time; requiring the Secretary to prepare and provide a certain application for
5 registering rifles and shotguns; providing that certain registration data is not open
6 to public inspection; prohibiting a certain person from selling, renting, or
7 transferring a certain rifle or shotgun unless the person presents a long gun
8 qualification license issued by the Secretary or certain credentials or identification;
9 providing for certain exceptions to the requirement to present and possess a long gun
10 qualification license under certain circumstances; establishing certain requirements
11 and procedures for the issuance and renewal of a long gun qualification license;
12 authorizing the Secretary to revoke a long gun qualification license under certain
13 circumstances; requiring a certain person to return a long gun qualification license
14 under certain circumstances; establishing certain requirements and procedures for
15 the issuance of a replacement long gun qualification license under certain
16 circumstances; authorizing the Secretary to adopt certain regulations; prohibiting a
17 certain dealer or other person from knowingly participating in the illegal sale, rental,
18 transfer, purchase, possession, or receipt of a certain rifle or shotgun under certain
19 circumstances; establishing certain penalties; defining certain terms; and generally
20 relating to rifles and shotguns.

31 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
32 That the Laws of Maryland read as follows:

35 (a) In this subtitle the following words have the meanings indicated.

36 (B) “DEALER’S LICENSE” MEANS A STATE-REGULATED FIREARMS
37 DEALER’S LICENSE.

1 (C) "IMMEDIATE FAMILY MEMBER" MEANS A SPOUSE, A PARENT, A
2 STEPPARENT, A GRANDPARENT, AN AUNT, AN UNCLE, A SIBLING, A STEPSIBLING, A
3 CHILD, A STEPCHILD, A GRANDCHILD, A NIECE, OR A NEPHEW, AS RELATED BY
4 BLOOD OR MARRIAGE.

5 (D) "LICENSEE" MEANS A PERSON WHO HOLDS A DEALER'S LICENSE.

6 [(b)] (E) "Rifle" has the meaning stated in § 4-201 of the Criminal Law Article.

7 (F) "SECRETARY" MEANS THE SECRETARY OF STATE POLICE.

8 [(c)] (G) "Short-barreled rifle" has the meaning stated in § 4-201 of the
9 Criminal Law Article.

10 [(d)] (H) "Short-barreled shotgun" has the meaning stated in § 4-201 of the
11 Criminal Law Article.

12 [(e)] (I) "Shotgun" has the meaning stated in § 4-201 of the Criminal Law
13 Article.

14 (J) "SPORT SHOOTING RANGE" HAS THE MEANING STATED IN § 5-403.1 OF
15 THE COURTS ARTICLE.

16 (K) "TRANSFER" MEANS A SALE, A RENTAL, A FURNISHING, A GIFT, A LOAN,
17 OR ANY OTHER DELIVERY, WITH OR WITHOUT CONSIDERATION.

18 (L) "TRANSFeree" MEANS A PERSON WHO RECEIVES OR INTENDS TO
19 RECEIVE A FIREARM IN A TRANSFER.

20 (M) "TRANSFEROR" MEANS A PERSON WHO DELIVERS OR INTENDS TO
21 DELIVER A FIREARM IN A TRANSFER.

23 (A) THIS SECTION DOES NOT APPLY TO A TRANSFER:

24 (1) INVOLVING A LICENSEE OR A FEDERALLY LICENSED GUN
25 MANUFACTURER, DEALER, OR IMPORTER;

26 (2) BETWEEN IMMEDIATE FAMILY MEMBERS;

27 (3) INVOLVING LAW ENFORCEMENT PERSONNEL OF ANY UNIT OF THE
28 FEDERAL GOVERNMENT, A MEMBER OF THE ARMED FORCES OF THE UNITED
29 STATES, A MEMBER OF THE NATIONAL GUARD, OR LAW ENFORCEMENT PERSONNEL

1 OF THE STATE OR ANY LOCAL AGENCY IN THE STATE, WHILE ACTING IN THE SCOPE
2 OF OFFICIAL DUTY;

3 (4) OF A CURIO OR RELIC FIREARM BETWEEN COLLECTORS WHO
4 EACH HAVE IN THEIR POSSESSION A VALID COLLECTOR OF CURIOS AND RELICS
5 LICENSE, AS THE TERMS ARE DEFINED IN FEDERAL LAW OR DETERMINATIONS
6 PUBLISHED BY THE BUREAU OF ALCOHOL, TOBACCO, FIREARMS, AND EXPLOSIVES;

7 (5) THAT IS TEMPORARY AND NECESSARY TO PREVENT IMMINENT
8 DEATH OR SERIOUS BODILY HARM IF THE TRANSFER LASTS ONLY AS LONG AS
9 NECESSARY TO PREVENT IMMINENT DEATH OR SERIOUS BODILY HARM;

10 (6) THAT OCCURS BY OPERATION OF LAW ON THE DEATH OF A PERSON
11 FOR WHOM THE TRANSFEREE IS AN EXECUTOR, AN ADMINISTRATOR, A TRUSTEE, OR
12 A PERSONAL REPRESENTATIVE OF AN ESTATE OR A TRUST CREATED IN A WILL;

13 (7) OF AN UNSERVICEABLE RIFLE OR SHOTGUN TRANSFERRED AS A
14 CURIO OR MUSEUM PIECE;

15 (8) OF A RIFLE OR SHOTGUN MODIFIED TO RENDER IT PERMANENTLY
16 INOPERATIVE; OR

17 (9) THAT IS TEMPORARY, OCCURS UNDER CIRCUMSTANCES IN WHICH
18 THE TRANSFEROR HAS NO REASON TO BELIEVE THAT THE TRANSFEREE INTENDS TO
19 USE THE RIFLE OR SHOTGUN IN THE COMMISSION OF A CRIME OR TO ALLOW
20 ANOTHER PERSON TO USE THE RIFLE OR SHOTGUN, AND TAKES PLACE
21 EXCLUSIVELY:

22 (I) AT AN ESTABLISHED SPORT SHOOTING RANGE OPERATED IN
23 ACCORDANCE WITH THE LOCAL LAW OF THE JURISDICTION IN WHICH THE RANGE IS
24 LOCATED;

25 (II) DURING A LAWFULLY ORGANIZED COMPETITION
26 INVOLVING THE USE OF A RIFLE OR SHOTGUN;

27 (III) DURING A PERFORMANCE OR A PRACTICE FOR A
28 PERFORMANCE BY AN ORGANIZED GROUP THAT USES RIFLES OR SHOTGUNS AS PART
29 OF THE PERFORMANCE;

30 (IV) WHILE THE TRANSFEREE IS HUNTING OR TRAPPING IF THE
31 HUNTING OR TRAPPING IS LEGAL IN ALL PLACES AND AT ALL TIMES WHEN THE
32 HUNTING OR TRAPPING IS CONDUCTED AND THE TRANSFEREE HOLDS ANY LICENSE
33 OR PERMIT REQUIRED FOR THE HUNTING OR TRAPPING; OR

1 (V) IN THE ACTUAL PRESENCE OF THE TRANSFEROR.

2 (B) A PERSON WHO IS NOT A LICENSEE MAY NOT COMPLETE THE TRANSFER
3 OF A RIFLE OR SHOTGUN OTHER THAN A REGULATED FIREARM, AS A TRANSFEREE
4 OR TRANSFEROR, UNLESS THE PERSON IS IN COMPLIANCE WITH THIS SECTION.

5 (C) (1) BEFORE A TRANSFER IS CONDUCTED, THE TRANSFEROR AND
6 TRANSFEREE SHALL MEET JOINTLY WITH A LICENSEE AND REQUEST THAT THE
7 LICENSEE FACILITATE THE TRANSFER.

8 (2) (I) A LICENSEE WHO AGREES TO FACILITATE A TRANSFER
9 UNDER THIS SECTION SHALL PROCESS THE TRANSFER AS THOUGH TRANSFERRING
10 THE RIFLE OR SHOTGUN FROM THE LICENSEE'S OWN INVENTORY TO THE
11 TRANSFEREE.

12 (II) THE LICENSEE SHALL COMPLY WITH ALL FEDERAL AND
13 STATE LAW THAT WOULD APPLY TO THE TRANSFER, INCLUDING ALL BACKGROUND
14 CHECK AND RECORD-KEEPING REQUIREMENTS.

15 (D) NOTWITHSTANDING ANY OTHER REQUIREMENTS OF LAW, THE
16 TRANSFEROR MAY REMOVE THE RIFLE OR SHOTGUN FROM THE PREMISES OF THE
17 LICENSEE OR A GUN SHOW WHILE A BACKGROUND CHECK IS BEING CONDUCTED,
18 BUT MUST SUBSEQUENTLY DELIVER THE RIFLE OR SHOTGUN TO THE LICENSEE TO
19 COMPLETE THE TRANSFER.

20 (E) (1) THE LICENSEE OR THE TRANSFEROR MAY NOT COMPLETE THE
21 TRANSFER TO THE TRANSFEREE IF THE RESULTS OF THE BACKGROUND CHECK
22 INDICATE THAT THE TRANSFEREE MAY NOT POSSESS THE RIFLE OR SHOTGUN.

23 (2) IF THE RESULTS OF THE BACKGROUND CHECK INDICATE THAT
24 THE TRANSFEREE MAY NOT POSSESS THE RIFLE OR SHOTGUN, THE TRANSFEROR
25 MAY REMOVE THE RIFLE OR SHOTGUN FROM THE PREMISES OF THE LICENSEE OR A
26 GUN SHOW.

27 (F) A LICENSEE MAY CHARGE A REASONABLE FEE FOR FACILITATING A
28 TRANSFER UNDER THIS SECTION.

29 (G) (1) EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS SUBSECTION, A
30 PERSON WHO VIOLATES THIS SECTION IS GUILTY OF A MISDEMEANOR AND ON
31 CONVICTION IS SUBJECT TO IMPRISONMENT NOT EXCEEDING 5 YEARS OR A FINE
32 NOT EXCEEDING \$10,000 OR BOTH.

1 **(2) A PERSON WHO PROVIDES FALSE INFORMATION WHILE**
2 **CONDUCTING A TRANSACTION UNDER THIS SECTION IS GUILTY OF A MISDEMEANOR**
3 **AND ON CONVICTION IS SUBJECT TO IMPRISONMENT NOT EXCEEDING 3 YEARS OR A**
4 **FINE NOT EXCEEDING \$5,000 OR BOTH.**

6 **(A) A LICENSEE OR ANY OTHER PERSON MAY NOT SELL, RENT, OR**
7 **TRANSFER A RIFLE OR SHOTGUN OTHER THAN A REGULATED FIREARM UNTIL 7 DAYS**
8 **AFTER A FEDERAL FIREARMS TRANSACTION RECORD IS EXECUTED BY THE**
9 **TRANSFeree, AND THE LICENSEE OR TRANSFEROR BEGINS TO PROCESS THE**
10 **TRANSACTION IN ACCORDANCE WITH STATE AND FEDERAL LAW.**

11 **(B) (1) (I) A LICENSEE OR ANY OTHER PERSON WHO SELLS, RENTS, OR**
12 **TRANSFERS A RIFLE OR SHOTGUN OTHER THAN A REGULATED FIREARM IN**
13 **COMPLIANCE WITH THIS SUBTITLE SHALL FORWARD A COPY OF THE WRITTEN**
14 **NOTIFICATION OF THE COMPLETED TRANSACTION TO THE SECRETARY WITHIN 7**
15 **DAYS AFTER DELIVERY OF THE RIFLE OR SHOTGUN.**

16 **(II) THE NOTIFICATION SHALL CONTAIN AN IDENTIFYING**
17 **DESCRIPTION OF THE FIREARM, INCLUDING ITS CALIBER, MAKE, MODEL, ANY**
18 **MANUFACTURER'S SERIAL NUMBER, AND ANY OTHER SPECIAL OR PECULIAR**
19 **CHARACTERISTIC OR MARKING BY WHICH THE FIREARM MAY BE IDENTIFIED.**

20 **(2) THE SECRETARY SHALL MAINTAIN A PERMANENT RECORD OF ALL**
21 **SUCH NOTIFICATIONS RECEIVED IN THE STATE.**

30 **(5) THE PURCHASE OF AN ANTIQUE FIREARM;**

1 **(6) A PURCHASE BY A LICENSEE;**

2 **(7) THE EXCHANGE OR REPLACEMENT OF A RIFLE OR SHOTGUN BY A**
3 **SELLER FOR A RIFLE OR SHOTGUN PURCHASED FROM THE SELLER BY THE SAME**
4 **PERSON SEEKING THE EXCHANGE OR REPLACEMENT WITHIN 30 DAYS IMMEDIATELY**
5 **BEFORE THE EXCHANGE OR REPLACEMENT; OR**

6 **(8) A PERSON WHOSE RIFLE OR SHOTGUN IS STOLEN OR**
7 **IRRETRIEVABLY LOST AND WHO CONSIDERS IT ESSENTIAL THAT THE RIFLE OR**
8 **SHOTGUN BE REPLACED IMMEDIATELY, IF:**

9 **(I) THE PERSON PROVIDES THE LICENSEE WITH A COPY OF THE**
10 **OFFICIAL POLICE REPORT OR AN OFFICIAL SUMMARY OF THE REPORT;**

11 **(II) THE OFFICIAL POLICE REPORT OR OFFICIAL SUMMARY OF**
12 **THE REPORT CONTAINS THE NAME AND ADDRESS OF THE RIFLE OR SHOTGUN**
13 **OWNER, A DESCRIPTION OF THE RIFLE OR SHOTGUN, THE LOCATION OF THE LOSS**
14 **OR THEFT, THE DATE OF THE LOSS OR THEFT, AND THE DATE WHEN THE LOSS OR**
15 **THEFT WAS REPORTED TO THE LAW ENFORCEMENT AGENCY; AND**

16 **(III) THE LOSS OR THEFT OCCURRED WITHIN 30 DAYS BEFORE**
17 **THE PERSON'S ATTEMPT TO REPLACE THE RIFLE OR SHOTGUN, AS REFLECTED BY**
18 **THE DATE OF LOSS OR THEFT ON THE OFFICIAL POLICE REPORT OR OFFICIAL**
19 **SUMMARY OF THE REPORT.**

20 **(B) A PERSON MAY NOT PURCHASE MORE THAN ONE RIFLE OR SHOTGUN**
21 **OTHER THAN A REGULATED FIREARM IN A 30-DAY PERIOD.**

22 **(C) A PERSON WHO VIOLATES THIS SECTION IS GUILTY OF A MISDEMEANOR**
23 **AND ON CONVICTION IS SUBJECT TO IMPRISONMENT NOT EXCEEDING 3 YEARS OR A**
24 **FINE NOT EXCEEDING \$5,000 OR BOTH.**

32 **SECTION.**

1 (B) AN APPLICATION FOR REGISTRATION UNDER THIS SECTION SHALL
2 CONTAIN:

3 (1) THE MAKE, MODEL, MANUFACTURER'S SERIAL NUMBER, CALIBER,
4 TYPE, BARREL LENGTH, FINISH, AND COUNTRY OF ORIGIN OF EACH RIFLE AND
5 SHOTGUN OTHER THAN A REGULATED FIREARM; AND

6 (2) THE OWNER'S NAME, ADDRESS, SOCIAL SECURITY NUMBER,
7 PLACE AND DATE OF BIRTH, HEIGHT, WEIGHT, RACE, EYE AND HAIR COLOR,
8 SIGNATURE, DRIVER'S OR PHOTOGRAPHIC IDENTIFICATION SOUNDINDEX NUMBER,
9 AND OCCUPATION.

10 (C) AN APPLICATION FOR REGISTRATION FILED WITH THE SECRETARY
11 SHALL BE ACCOMPANIED BY A NONREFUNDABLE TOTAL REGISTRATION FEE OF \$15,
12 REGARDLESS OF THE NUMBER OF FIREARMS REGISTERED.

13 (D) REGISTRATION DATA PROVIDED UNDER THIS SECTION IS NOT OPEN TO
14 PUBLIC INSPECTION.

17 (1) A LICENSED FIREARMS MANUFACTURER;

18 (2) A LAW ENFORCEMENT OFFICER OR PERSON WHO IS RETIRED IN
19 GOOD STANDING FROM SERVICE WITH A LAW ENFORCEMENT AGENCY OF THE
20 UNITED STATES, THE STATE, OR A LOCAL LAW ENFORCEMENT AGENCY OF THE
21 STATE;

22 (3) A MEMBER OR RETIRED MEMBER OF THE ARMED FORCES OF THE
23 UNITED STATES OR THE NATIONAL GUARD; OR

24 (4) A PERSON PURCHASING, RENTING, OR RECEIVING AN ANTIQUE,
25 CURIO, OR RELIC FIREARM, AS DEFINED IN FEDERAL LAW OR IN DETERMINATIONS
26 PUBLISHED BY THE BUREAU OF ALCOHOL, TOBACCO, FIREARMS AND EXPLOSIVES.

27 (B) A DEALER OR ANY OTHER PERSON MAY NOT SELL, RENT, OR TRANSFER
28 A RIFLE OR SHOTGUN OTHER THAN A REGULATED FIREARM TO A PURCHASER,
29 LESSEE, OR TRANSFEREE UNLESS THE PURCHASER, LESSEE, OR TRANSFEREE
30 PRESENTS TO THE DEALER OR OTHER PERSON A VALID LONG GUN QUALIFICATION
31 LICENSE ISSUED TO THE PURCHASER, LESSEE, OR TRANSFEREE BY THE SECRETARY
32 UNDER THIS SECTION.

1 (C) A PERSON MAY PURCHASE, RENT, OR RECEIVE A RIFLE OR SHOTGUN
2 ONLY IF THE PERSON:

3 (1) (I) POSSESSES A VALID LONG GUN QUALIFICATION LICENSE
4 ISSUED TO THE PERSON BY THE SECRETARY IN ACCORDANCE WITH THIS SECTION;

5 (II) POSSESSES VALID CREDENTIALS FROM A LAW
6 ENFORCEMENT AGENCY OR RETIREMENT CREDENTIALS FROM A LAW
7 ENFORCEMENT AGENCY;

8 (III) IS AN ACTIVE OR RETIRED MEMBER OF THE ARMED FORCES
9 OF THE UNITED STATES OR THE NATIONAL GUARD AND POSSESSES A VALID
10 MILITARY IDENTIFICATION CARD; OR

11 (IV) IS PURCHASING, RENTING, OR RECEIVING AN ANTIQUE,
12 CURIO, OR RELIC FIREARM, AS DEFINED IN FEDERAL LAW OR IN DETERMINATIONS
13 PUBLISHED BY THE BUREAU OF ALCOHOL, TOBACCO, FIREARMS AND EXPLOSIVES;
14 AND

15 (2) IS NOT OTHERWISE PROHIBITED FROM PURCHASING OR
16 POSSESSING A RIFLE OR SHOTGUN OTHER THAN A REGULATED FIREARM UNDER
17 STATE OR FEDERAL LAW.

18 (D) SUBJECT TO SUBSECTIONS (F) AND (G) OF THIS SECTION, THE
19 SECRETARY SHALL ISSUE A LONG GUN QUALIFICATION LICENSE TO A PERSON WHO
20 THE SECRETARY FINDS:

21 (1) IS AT LEAST 18 YEARS OLD;

22 (2) IS A RESIDENT OF THE STATE;

23 (3) EXCEPT AS PROVIDED IN SUBSECTION (E) OF THIS SECTION, HAS
24 DEMONSTRATED SATISFACTORY COMPLETION, WITHIN 3 YEARS PRIOR TO THE
25 SUBMISSION OF THE APPLICATION, OF A FIREARMS SAFETY TRAINING COURSE
