CHAPTER _____

1 AN ACT concerning

2 **State Public Transit Service and Stations – Exclusion for Assault and Bodily**
3 **Injury**

4 FOR the purpose of providing that a certain person alleged to have committed an assault
5 or other intentional act causing bodily injury may ~~not board~~ be prohibited from using
6 a State public transit service or ~~enter~~ entering a State public transit service station
7 ~~for a certain period of time and under certain circumstances~~; requiring the Maryland
8 Transit Administration to create a rider code of conduct and implement a
9 comprehensive internal safety program to strengthen protections for operators and
10 passengers; and generally relating to excluding ~~individuals~~ persons who commit
11 assault or acts resulting in bodily injury from State public transit services and
12 stations.

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

19 That the Laws of Maryland read as follows:

20 **Article – Transportation**

3 INDICATED.

4 (2) (I) "PUBLIC TRANSIT OPERATOR" HAS THE MEANING STATED
5 IN §7-714 OF THIS SUBTITLE.

6 (II) "PUBLIC TRANSIT OPERATOR" INCLUDES A PERSON
7 ENGAGED IN OFFICIAL DUTIES AS A STATION AGENT, CONDUCTOR, OR STATION
8 ATTENDANT WHO IS EMPLOYED BY:

9 1. AN ENTITY THAT PROVIDES TRANSIT SERVICE UNDER
10 CONTRACT WITH THE ADMINISTRATION;

11 2. A PRIVATE ENTITY THAT PROVIDES PUBLIC TRANSIT
12 SERVICE; AND

13 3. AN ENTITY THAT PROVIDES TRANSIT SERVICE UNDER
14 A TRANSPORTATION COMPACT UNDER TITLE 10 OF THIS ARTICLE.

15 (3) "STATE PUBLIC TRANSIT SERVICE" MEANS ANY OF THE

10 ~~(3) THE REMAINDER OF THE PERSON'S LIFE;~~

11 ~~(I) FOR A THIRD ACT OF ASSAULT OR INTENTIONAL ACT~~

13 ~~(II) FOR ANY ACT OF ASSAULT OR INTENTIONAL ACT CAUSING~~

25 SECTION 2. AND BE IT FURTHER ENACTED, That:

26 (a) On or before June 1, 2025, the Maryland Transit Administration, in
27 consultation with the Washington Metropolitan Area Transit Authority, the Joint Safety
28 Committee, and operator union representatives, shall convene a workgroup to create a rider
29 code of conduct and implement a comprehensive internal safety program to strengthen
30 protections for Administration operators and passengers through clear safety protocols,
31 strengthened safety policies, and improved risk mitigation measures.

32 (b) The workgroup:

1 (1) shall address consequences for violations in Administration facilities
2 that shall include ridership bans for an assault on a public transit operator or passenger as
3 soon as practicable, the possibility of legal action, and an appeals process;

4 (2) may not require a criminal conviction as a prerequisite to a ban on
5 public transit service usage; and

6 (3) shall authorize, under standards set by the workgroup, the use of public
7 transit facilities by a person accused of assault on a public transit operator or passenger, if
8 the assault was directly related to the person's disability and the person is accompanied by
9 a direct support professional or another appropriate caregiver when using public transit
10 facilities.

11 (c) On or before October 1, 2025, the workgroup shall report its findings and
12 recommendations to the Maryland Transit Administrator and, in accordance with § 2-1257
13 of the State Government Article, the Senate Finance Committee and the House
14 Environment and Transportation Committee.

15 (d) After issuing the report under subsection (c) of this section, the workgroup
16 shall continue to assess the effectiveness of the proposed code of conduct and internal safety
17 program and recommend ongoing improvements.

18 SECTION 3. AND BE IT FURTHER ENACTED, That:

19 (1) if the Maryland Transit Administration adopts a rider code of conduct
20 and implements a comprehensive internal safety program, with no further action required
21 by the General Assembly, Section 1 of this Act shall be abrogated and of no further force
22 and effect; and

23 (2) the Maryland Transit Administration shall notify the Department of
24 Legislative Services within 5 days after adoption of the rider code of conduct and
25 implementation of a comprehensive internal safety program as described in Section 2 of
26 this Act.

27 SECTION ~~2~~ 4. AND BE IT FURTHER ENACTED, That this Act shall take effect
