AN ACT

To amend chapter 27, RSMo, by adding thereto one new section relating to firearms.

Be it enacted by the General Assembly of the state of Missouri, as follows:

Section A. Chapter 27, RSMo, is amended by adding thereto one new section, to be
2 known as section 27.126, to read as follows:

**27.126. 1. The attorney general shall establish or contract for the establishment
2 of a firearm-owner registry.**

**3 2. The firearm-owner registry shall consist of hard copies of the firearm catalog
4 form described under subsection 4 of this section and shall also be implemented in the
5 form of an electronic database, which shall be searchable using the criteria enumerated
6 under subsection 3 of this section.**

**7 3. The firearm-owner registry shall be confidential and closed to the public. The
8 attorney general may release confidential information to law enforcement agencies
9 pursuant to a warrant. The attorney general may also release anonymous aggregate
10 data regarding the number of:**

11 (1) Firearms registered in a zip code;

12 (2) Firearms registered by residents and nonresidents; and

13 (3) Each model of firearm registered.

**14 4. The attorney general shall create and make available, both on the attorney
15 general website and at courthouses in this state, a firearm catalog form. At a minimum,
16 the form shall require the following information:**

17 (1) The full name of the firearm owner;

18 (2) The address of the firearm owner;

- 19 **(3) Whether the firearm owner is a Missouri resident;**
 - 20 **(4) The date of birth of the firearm owner;**
 - 21 **(5) The date of filing;**
 - 22 **(6) Whether the firearm owner has filed previously;**
 - 23 **(7) The type, model, serial number, and gauge or caliber of each of the owner's**
 - 24 **firearms; and**
 - 25 **(8) An affidavit statement that the information contained in the form is true,**
 - 26 **accurate, and complete.**
- 27 **5. Each calendar year, each resident of the state who owns a firearm may fill out**
- 28 **the firearm catalog form and submit the completed form to the attorney general before**
- 29 **March first.**
- 30 **6. Within ten days of either entering the state with a firearm or acquiring a**
- 31 **firearm while in this state, each nonresident of the state who possesses a firearm may fill**
- 32 **out the firearm catalog form and submit the completed form to the attorney general.**
