Amend SS/SCS/Senate Bill No. 152, Page 1, Section A, Line 5,

by inserting after all of said line the following: 2 "162.441. 1. If any school district desires to be 3 attached to a community college district organized under 4 sections 178.770 to 178.890 or to one or more adjacent seven-5 director school districts for school purposes, upon the 6 7 receipt of a petition setting forth such fact, signed either by voters of the district equal in number to ten percent of 8 9 those voting in the last school election at which school board members were elected or by a majority of the voters of 10 the district, whichever is the lesser, the school board of 11 12 the district desiring to be so attached shall submit the question to the voters. 13

2. As an alternative to the procedure in subsection 1 14 15 of this section, a seven-director district may, by a majority vote of its board of education, propose a plan to 16 the voters of the district to attach the district to one or 17 more adjacent seven-director districts and call an election 18 upon the question of such plan. 19

20 3. As an alternative to the procedures in subsection 1 or 2 of this section, a community college district organized 21 under sections 178.770 to 178.890 may, by a majority vote of 22 23 its board of trustees, propose a plan to the voters of the school district to attach the school district to the 24 community college district, levy the tax rate applicable to 25 the community college district at the time of the vote of 26

27 the board of trustees and a majority vote of the county commission of the county or counties in which the community 28 29 college district is located, and call an election upon the question of such plan. The tax rate applicable to the 30 community college district shall not be levied as to the 31 school district until the proposal by the board of trustees 32 33 of the community college district has been approved by a majority vote of the voters of the school district at the 34 election called for that purpose. The community college 35 36 district shall be responsible for the costs associated with the election. 37

38 4. A plat of the proposed changes to all affected39 districts shall be published and posted with the notice of40 election.

41 5. The question shall be submitted in substantially42 the following form:

If a majority of the votes cast in the district 46 6. proposing annexation favor annexation, the secretary shall 47 certify the fact, with a copy of the record, to the board of 48 the district and to the boards of the districts to which 49 annexation is proposed; whereupon the boards of the seven-50 director districts to which annexation is proposed shall 51 52 meet to consider the advisability of receiving the district or a portion thereof, and if a majority of all the members 53 of each board favor annexation, the boundary lines of the 54 seven-director school districts from the effective date 55 shall be changed to include the district, and the board 56 shall immediately notify the secretary of the district which 57 has been annexed of its action. 58

59 7. Upon the effective date of the annexation, all 60 indebtedness, property and money on hand belonging thereto 61 shall immediately pass to the seven-director school 62 district. If the district is annexed to more than one 63 district, the provisions of sections 162.031 and 162.041 64 shall apply."; and 65 Further amend the title and enacting clause accordingly.
