6 A BILL FOR AN ACT ENTITLED: "AN ACT ENSURING THE AVAILABILITY OF MONTANA AMMUNITION;  
7 ENCOURAGING THE FORMATION OF BUSINESS IN MONTANA PRIMARILY ENGAGED IN THE  
8 MANUFACTURE OF AMMUNITION COMPONENTS; PROVIDING EXEMPTIONS FROM PROPERTY TAXES;  
9 ~~INDIVIDUAL INCOME TAXES, CORPORATE INCOME TAXES, AND OTHER BUSINESS-RELATED TAXES~~

19 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:  
20

21 NEW SECTION. **Section 1. Short title.** [Sections 1 through 7 6] may be cited as the "Montana  
22 Ammunition Availability Act".  
23

24 NEW SECTION. **Section 2. Legislative findings.** (1) In recognition that the people of Montana have  
25 reserved to themselves the individual right to bear arms in Article II, section 12, of the Montana constitution, the  
26 legislature finds that both this right and the firearms that the people possess are at serious risk if the people  
27 cannot obtain ammunition for firearms. An adequate source of ammunition is an indivisible and essential part of  
28 the right to bear arms. The people of Montana are totally dependent upon a very few manufacturers of smokeless  
29 propellant, small arms primers, and cartridge cases located in other states for small arms ammunition used in  
30 Montana.

1 (2) The legislature intends to encourage the manufacture of smokeless propellant, small arms primers,  
 2 and cartridge cases within the borders of Montana to ensure availability of small arms ammunition for the people  
 3 of Montana and to fully implement the right to bear arms that the people have reserved to themselves.

4  
 5 **NEW SECTION. Section 3. Definitions.** As used in [sections 1 through 7 6], the following definitions  
 6 apply:

7 (1) "Ammunition components" means propellants, primers, and cartridge cases.

8 (2) "Black powder" means a propellant made from potassium or sodium nitrate, charcoal, and sulfur or  
 9 a substitute for black powder made differently that is used for conventional small arms or antique or replica arms.

10 (3) "Cartridge cases" means the casings that contain and hold together the propellant, primer, and bullet,  
 11 which may be formed from brass, aluminum, steel, plastic, or some combination of those or other materials.

12 (4) "Primary business" means a manufacturer in which more than one-half of its product produced is and  
 13 more than one-half of its gross income comes from sales of ammunition components.

14 (5) "Propellant" includes smokeless propellant and black powder.

15 (6) "Small arms" means pistols, revolvers, rifles, shotguns, and other similar devices that are portable  
 16 by one person, the possession and use of which are protected by Article II, section 12, of the Montana  
 17 constitution.

18 (7) "Small arms primers" means the priming component for a round of ammunition intended for use in  
 19 small arms that is usually made of a cup, an anvil, and a shock-sensitive chemical compound and is designed  
 20 to ignite the propellant in an ammunition cartridge for conventional small arms.

21 (8) "Smokeless propellant" means a chemical substance designed to expel a projectile from small arms  
 22 through burning and expansion at a quick but controlled burning rate.

23  
 24 **NEW SECTION. Section 4. ~~Tax exemptions~~ PROPERTY TAX EXEMPTION for manufacturing of**  
 25 **ammunition components -- conditions -- real property exemption applies to safety zone.** (1) A person or  
 26 entity in this state engaged in the primary business of the manufacture of ammunition components that meets  
 27 the conditions in subsections (2) through (4) is exempt from:

28 (a) property taxes levied for state educational purposes under 15-10-108, 20-9-331, 20-9-333, 20-9-360,  
 29 and 20-25-439; AND

30 (b) business equipment tax levied pursuant to 15-6-138;

- 1 ~~—— (c) individual income taxes as provided in Title 15, chapter 30;~~  
 2 ~~—— (d) corporate income or alternative corporate income taxes as provided in Title 15, chapter 31; and~~  
 3 ~~—— (e) any other tax on business activity levied by the state, except:~~  
 4 ~~—— (i) the local portion of property tax not exempt under subsection (1)(a); or~~  
 5 ~~—— (ii) an employer's share of employee payroll taxes that are used to finance state-mandated programs,~~  
 6 ~~including unemployment insurance and workers' compensation.~~

7 (2) A person or entity in this state engaged in the primary business of the manufacture of ammunition  
 8 components is exempt from PROPERTY taxation as provided under subsection (1) if the person's or entity's  
 9 business meets the following conditions:

10 (a) the products of the business are and remain available to commercial and individual consumers in  
 11 the state;

12 (b) the business sells its products to in-state commercial and individual consumers for a price no greater  
 13 than that for out-of-state purchasers, including any products that leave the state regardless of destination or  
 14 purchaser; and

15 (c) the business does not enter into any agreement or contract that could actually or potentially command  
 16 or commit all of its production to out-of-state consumers or interfere with or prohibit sales and provision of  
 17 products to in-state consumers.

18 (3) The exemptions allowed under subsection (1) apply only to the property, ~~income,~~ and business  
 19 activity attributable to the manufacture of ammunition components.

20 (4) The real property exemption allowed under subsection (1)(a) encompasses any property within 500  
 21 yards of a structure used for the manufacture of ammunition components or of any structure used for storage of  
 22 products manufactured onsite.

 24 ~~—— **NEW SECTION. Section 5. Tax exemptions for providing loans to manufacturer of ammunition**~~  
 25 ~~**components — conditions.** (1) Subject to subsection (2), a lender or investor that provides loans to a person~~  
 26 ~~or entity in this state engaged in the primary business of the manufacture of ammunition components under the~~  
 27 ~~provisions of [section 4] is exempt from:~~

28 ~~—— (a) individual income taxes as provided in Title 15, chapter 30; and~~

29 ~~—— (b) corporate income or alternative corporate income taxes as provided in Title 15, chapter 31.~~

30 ~~—— (2) The exemption provided for in this section:~~

1 ~~\_\_\_\_\_ (a) does not apply to an employer's share of employee payroll taxes that are used to finance~~  
 2 ~~state-mandated programs, including unemployment insurance and workers' compensation; and~~

3 ~~\_\_\_\_\_ (b) may be claimed only for income attributable to providing a bona fide loan in an arm's-length~~  
 4 ~~transaction to a manufacturer of ammunition components that satisfies the conditions of [section 4].~~

5  
 6 **NEW SECTION. Section 5. Tort liability.** The provisions of 27-1-720 apply to ammunition components  
 7 manufactured in Montana.

8  
 9 **NEW SECTION. Section 6. Economic development.** The establishment of a primary business is a  
 10 qualified economic development purpose pursuant to ~~90-1-116~~ 90-1-117 through 90-1-119 and Title 90, chapter  
 11 1, part 2.

12  
 13 **Section 7.** Section 15-6-219, MCA, is amended to read:

14 **"15-6-219. Personal and other property exemptions.** The following categories of property are exempt  
 15 from taxation:

16 (1) harness, saddlery, and other tack equipment;  
 17 (2) the first \$15,000 or less of market value of tools owned by the taxpayer that are customarily  
 18 hand-held and that are used to:

19 (a) construct, repair, and maintain improvements to real property; or  
 20 (b) repair and maintain machinery, equipment, appliances, or other personal property;  
 21 (3) all household goods and furniture, including but not limited to clocks, musical instruments, sewing  
 22 machines, and wearing apparel of members of the family, used by the owner for personal and domestic purposes  
 23 or for furnishing or equipping the family residence;

24 (4) a bicycle, as defined in 61-8-102, used by the owner for personal transportation purposes;  
 25 (5) items of personal property intended for rent or lease in the ordinary course of business if each item  
 26 of personal property satisfies all of the following:

27 (a) the acquired cost of the personal property is less than \$15,000;  
 28 (b) the personal property is owned by a business whose primary business income is from rental or lease  
 29 of personal property to individuals and no one customer of the business accounts for more than 10% of the total  
 30 rentals or leases during a calendar year; and

1 (c) the lease of the personal property is generally on an hourly, daily, weekly, semimonthly, or monthly  
2 basis;

3 (6) space vehicles and all machinery, fixtures, equipment, and tools used in the design, manufacture,  
4 launch, repair, and maintenance of space vehicles that are owned by businesses engaged in manufacturing and  
5 launching space vehicles in the state or that are owned by a contractor or subcontractor of that business and that  
6 are directly used for space vehicle design, manufacture, launch, repair, and maintenance; ~~and~~

7 (7) a title plant owned by a title insurer or a title insurance producer, as those terms are defined in  
8 33-25-105; and

9 (8) personal property used in the manufacture of ammunition components as provided in [section 4]."  
10

11 NEW SECTION. Section 8. Manufacturer of ammunition components -- exemption from statewide  
12 property taxes. As provided in [section 4], property used in the manufacture of ammunition components is  
13 exempt from the property taxes levied for state educational purposes under 15-10-108, 20-9-331, 20-9-333,  
14 20-9-360, and 20-25-439. The exemption must be administered and applied for as provided in [sections 1  
15 through 7 6].
