- 1 A BILL FOR AN ACT relating to firearms; to amend sections 69-2426 and
- 2 69-2432, Reissue Revised Statutes of Nebraska; to require
- 3 dissemination of information regarding suicide prevention and
- 4 require suicide prevention training; to harmonize provisions; and to
- 5 repeal the original sections.
- 6 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 69-2426, Reissue Revised Statutes of Nebraska, is

- 2 amended to read:
- 3 69-2426 (1) Any firearm dealer licensed pursuant to 18 U.S.C. 923
- 4 Dealers of firearms shall distribute to all firearm purchasers
- 5 information developed by the Department of Health and Human Services
- 6 regarding:
- 7 (a) The the dangers of leaving loaded firearms unattended around
- 8 children; and -
- 9 (b) Suicide prevention, including materials that provide evidence-
- 10 <u>based information aligned with best practices in suicide prevention. Such</u>
- 11 <u>materials shall include information on the 988 Suicide and Crisis</u>
- 12 Lifeline.
- 13 (2) There is hereby created the Firearm Information Fund. Private
- 14 contributions shall be credited by the State Treasurer to such fund for
- 15 the implementation of the provisions of this section.
- Sec. 2. Section 69-2432, Reissue Revised Statutes of Nebraska, is
- 17 amended to read:
- 18 69-2432 (1) The Nebraska State Patrol shall prepare and publish
- 19 minimum training and safety requirements for and adopt and promulgate
- 20 rules and regulations governing handgun training and safety courses and
- 21 handgun training and safety course instructors. Minimum safety and
- 22 training requirements for a handgun training and safety course shall
- 23 include, but not be limited to:
- 24 (a) Knowledge and safe handling of a handgun;
- (b) Knowledge and safe handling of handgun ammunition;
- 26 (c) Safe handgun shooting fundamentals;
- 27 (d) A demonstration of competency with a handgun with respect to the
- 28 minimum safety and training requirements;
- (e) Knowledge of federal, state, and local laws pertaining to the
- 30 purchase, ownership, transportation, and possession of handguns;
- 31 (f) Knowledge of federal, state, and local laws pertaining to the

- 1 use of a handgun, including, but not limited to, use of a handgun for
- 2 self-defense and laws relating to justifiable homicide and the various
- 3 degrees of assault;
- 4 (g) Knowledge of ways to avoid a criminal attack and to defuse or
- 5 control a violent confrontation; and
- 6 (h) Knowledge of proper storage practices for handguns and
- 7 ammunition, including storage practices which would reduce the
- 8 possibility of accidental injury to a child; and -
- 9 (i) Suicide prevention training. Such training shall consist of
- 10 <u>evidence-based information aligned with best practices in suicide</u>
- 11 prevention.
- 12 (2) A person or entity conducting a handgun training and safety
- 13 course and the course instructors shall be approved by the patrol before
- operation. The patrol shall issue a certificate evidencing its approval.
- 15 (3) A certificate of completion of a handgun training and safety
- 16 course shall be issued by the person or entity conducting a handgun
- 17 training and safety course to persons successfully completing the course.
- 18 The certificate of completion shall also include certification from the
- 19 instructor that the person completing the course does not suffer from a
- 20 readily discernible physical infirmity that prevents the person from
- 21 safely handling a handgun.
- 22 (4) Any fee for participation in a handgun training and safety
- 23 course is the responsibility of the applicant.

- 25 Statutes of Nebraska, are repealed.
