SUMMARY—Makes appropriations to the Other State Education Programs Account for allocation to certain nonprofit organizations for the creation and maintenance of school gardens and to certain other nonprofit organizations. (BDR S-539)

AN ACT relating to governmental financial administration; making an appropriation for allocation to nonprofit organizations to provide programs for the creation and maintenance of school gardens; making appropriations to certain other nonprofit organizations; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** 1. There is hereby appropriated from the State
2 General Fund to the Other State Education Programs Account in the
3 State General Fund for the cost of creating and maintaining
4 programs for school gardens that meet the requirements of
5 subsection 3 the following sums:
6 For the Fiscal Year 2025-2026..... \$200,000
7 For the Fiscal Year 2026-2027..... \$200,000
8 2. The Department of Education shall allocate the money
9 appropriated by subsection 1 to nonprofit organizations to provide at

1 a public school a program for a school garden which meets the
2 requirements set forth in subsection 3.

3 3. For a nonprofit organization to receive an allocation of
4 money to provide a program for a school garden pursuant to
5 subsection 2, the program must:

6 (a) Create and maintain a school garden at the school.

7 (b) Have a curriculum that:

8 (1) Includes a comprehensive science, technology,
9 engineering and mathematics school garden program. Such a
10 program must include, without limitation, a science, technology,
11 engineering and mathematics curriculum for outdoor or hydroponic
12 gardens for pupils in kindergarten through grade 12 that is tailored
13 to pupils of the appropriate grade levels at the school;

14 (2) Is written specifically for Nevada and the desert
15 environment of Nevada;

16 (3) Complies with the standards of content and performance
17 for a course of study in science adopted by the State Board of
18 Education pursuant to NRS 389.520;

19 (4) Uses experiential learning or project-based learning to
20 teach science, technology, engineering, arts and mathematics;

21 (5) Is designed with the assistance of teachers and other
22 educational personnel with experience at the appropriate grade
23 levels at the school; and

24 (6) Involves supervised learning experiences for the pupils at
25 the school in a classroom and a school garden.

26 (c) Provide the school with assistance from members of the
27 community, including, without limitation, trained educators, local
28 farmers and local chefs.

29 (d) Provide pupils with the:

30 (1) Ability to operate a farmer's market to sell the produce
31 from the school garden; and

32 (2) Opportunity to have a local chef or employee of a school
33 who works in food services demonstrate how to cook a meal using
34 the produce grown from the school garden.

35 (e) Establish garden teams comprised of teachers and, if such
36 persons are available, parents and members of the community. Each
37 garden team shall meet at least once each month.

38 (f) Require any local nonprofit or community-based
39 organization which will provide services to implement the program
40 for a school garden to have at least 2 years of experience
41 implementing such a program.

42 4. Money allocated pursuant to subsection 2 may be used to:

43 (a) Provide professional development for teachers regarding the:

44 (1) Use of a school garden to teach pupils with disabilities,
45 including, without limitation, training for teaching such pupils



1 science, technology, engineering and mathematics curriculum and
2 vocational training to create a career path in horticulture;

3 (2) Development and implementation of science, technology,
4 engineering, arts and mathematics curricula that incorporate the use
5 of a school garden;

6 (3) Development and implementation of training that may be
7 provided to a group or individually to teachers in how to establish
8 and maintain school gardens to increase the time teachers allocate to
9 teaching science, technology, engineering and mathematics; and

10 (4) Development and implementation of a food safety plan
11 designed to ensure that food grown in a school garden is properly
12 handled and safe to sell and consume;

13 (b) Pay for any travel expenses associated with the attendance of
14 a teacher at any training or conference relating to school gardens;
15 and

16 (c) Pay for the costs of a conference regarding school gardens
17 held in this State.

18 5. As used in this section:

19 (a) "Public school" has the meaning ascribed to it in
20 NRS 385.007.

21 (b) "School garden" includes, without limitation, a hydroponic
22 garden.

23 **Sec. 2.** Upon acceptance of the money allocated pursuant to
24 section 1 of this act, a nonprofit organization agrees to:

25 1. Prepare and transmit a report to the Interim Finance
26 Committee on or before October 1, 2026, that describes each
27 expenditure made from the money allocated pursuant to section 1 of
28 this act from the date on which the money was received by the
29 nonprofit organization through June 30, 2026;

30 2. Prepare and transmit a final report to the Interim Finance
31 Committee on or before October 1, 2027, that describes each
32 expenditure made from the money allocated pursuant to section 1 of
33 this act from the date on which the money was received by the
34 nonprofit organization through June 30, 2027; and

35 3. Upon request of the Legislative Commission, make available
36 to the Legislative Auditor any of the books, accounts, claims,
37 reports, vouchers or other records of information, confidential or
38 otherwise, of the nonprofit organization, regardless of their form or
39 location, that the Legislative Auditor deems necessary to conduct an
40 audit of the use of the money allocated pursuant to section 1 of this
41 act.

42 **Sec. 3.** Any balance of the sums appropriated by section 1 of
43 this act remaining at the end of the respective fiscal years must not
44 be committed for expenditure after June 30 of the respective fiscal
45 years by the entity to which the appropriation is made or any entity



1 to which money from the appropriation is granted or otherwise
2 transferred in any manner, and any portion of the appropriated
3 money remaining must not be spent for any purpose after
4 September 18, 2026, and September 17, 2027, respectively, by
5 either the entity to which the money was appropriated or the entity
6 to which the money was subsequently granted or transferred, and
7 must be reverted to the State General Fund on or before
8 September 18, 2026, and September 17, 2027, respectively.

9 **Sec. 4.** 1. There is hereby appropriated from the State
10 General Fund to the Mob Museum the sum of \$250,000 for the
11 planning phase of its expansion.

12 2. Any remaining balance of the appropriation made by
13 subsection 1 must not be committed for expenditure after June 30,
14 2027, by the entity to which the appropriation is made or any entity
15 to which money from the appropriation is granted or otherwise
16 transferred in any manner, and any portion of the appropriated
17 money remaining must not be spent for any purpose after
18 September 17, 2027, by either the entity to which the money was
19 appropriated or the entity to which the money was subsequently
20 granted or transferred, and must be reverted to the State General
21 Fund on or before September 17, 2027.

22 **Sec. 5.** 1. There is hereby appropriated from the State
23 General Fund to the National Council of Juvenile and Family Court
24 Judges the sum of \$100,000 for the purpose of supporting the
25 Nevada Judicial Resource Center on Firearms.

26 2. Any remaining balance of the appropriation made by
27 subsection 1 must not be committed for expenditure after June 30,
28 2027, by the entity to which the appropriation is made or any entity
29 to which money from the appropriation is granted or otherwise
30 transferred in any manner, and any portion of the appropriated
31 money remaining must not be spent for any purpose after
32 September 17, 2027, by either the entity to which the money was
33 appropriated or the entity to which the money was subsequently
34 granted or transferred, and must be reverted to the State General
35 Fund on or before September 17, 2027.

36 **Sec. 6.** 1. There is hereby appropriated from the State
37 General Fund to Raise the Future the sum of \$250,000 to support its
38 programs in this State.

39 2. Any remaining balance of the appropriation made by
40 subsection 1 must not be committed for expenditure after June 30,
41 2027, by the entity to which the appropriation is made or any entity
42 to which money from the appropriation is granted or otherwise
43 transferred in any manner, and any portion of the appropriated
44 money remaining must not be spent for any purpose after
45 September 17, 2027, by either the entity to which the money was



1 appropriated or the entity to which the money was subsequently
2 granted or transferred, and must be reverted to the State General
3 Fund on or before September 17, 2027.

4 **Sec. 7.** This act becomes effective on July 1, 2025.
