To enact section 9.681 of	the Revised Code to	1
establish the Firearms	Industry	2

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:

Section 1. That section 9.681 of the Revised Code be	4
enacted to read as follows:	5
Sec. 9.681. (A) As used in this section:	6
"Firearm entity" means a shooting range or a firearm,	7
firearm accessory, or ammunition manufacturer, distributor,	8
wholesaler, supplier, or retailer.	9
"Full-time employee" means an employee who is employed an	10
average of at least twenty-five hours per week.	
"Governmental entity" means the state and any political	12
subdivision of the state.	
"Political subdivision" means a county, township,	14
municipal corporation, or any other body corporate and politic	15

that is responsible for government activities in a geographic	16
area smaller than that of the state.	
"State" means the state of Ohio, including the general	18
assembly, the supreme court, the offices of all elected state	
officers, and all departments, boards, offices, commissions,	20
agencies, colleges and universities, institutions, and other	
instrumentalities of the state of Ohio.	22
"Trade association" means an entity to which all of the	23
following apply:	24
(1) The entity is a corporation, unincorporated	25
association, federation, business league, or professional or	26
business organization not organized or operated for profit.	27
(2) No part of the net earnings of the entity inures to	28
the benefit of any private shareholder or individual.	29
(3) The entity is an organization described in 26 U.S.C.	30
501(c)(6) and exempt from federal income taxation pursuant to 26	
<u>U.S.C. 501(a).</u>	32
(4) Two or more members of the entity are manufacturers or	33
sellers of a qualified product, as defined by 15 U.S.C. 7903(4).	34
(B) This section applies only to a contract that is	35
entered into after the effective date of this section and that	36
does both of the following:

(1) Is between a governmental entity and a company with	38
ten or more full-time employees;	
(2) Has a value of one hundred thousand dollars or more	40
that is to be paid wholly or partly from public funds of the	41
governmental entity.

(C) A governmental entity may not enter into a contract	
with a company for goods or services unless the contract	44
contains a written verification of both of the following:	45
(1) The company does not have any internal practice,	46
policy, guidance, or directive, written or unwritten, that	47
discriminates against a firearm entity or firearm trade	48
association.	49
(2) The company will not discriminate against a firearm	50
entity or firearm trade association during the term of the	51
<u>contract.</u>	52
Section 2. This act shall be known as the Firearms	53
Industry Nondiscrimination Act.	
Section 3. The items of law contained in this act, and	55
their applications, are severable. If any item of law contained	56
in this act, or if any application of any item of law contained	57
in this act, is held invalid, the invalidity does not affect	58
other items of law contained in this act and their applications	59
that can be given effect without the invalid item of law or	60
application.	61
