## AN ACT

Amending Title 18 (Crimes and Offenses) of the Pennsylvania 1 Consolidated Statutes, in falsification and intimidation, 2 further providing for the offense of unsworn falsification to authorities; and, in firearms and other dangerous articles, further providing for persons not to possess, use, manufacture, control, sell or transfer firearms, for licenses 6 and for sale or transfer of firearms. 8 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 10 Section 1. Section 4904(b) of Title 18 of the Pennsylvania Consolidated Statutes is amended to read: 11 12 § 4904. Unsworn falsification to authorities. 13 (b) Statements "under penalty".--[A] 14 15 (1) Except as provided in paragraph (2), a person 16 commits a misdemeanor of the third degree if he makes a 17 written false statement which he does not believe to be true, 18 on or pursuant to a form bearing notice, authorized by law, to the effect that false statements made therein are 19

7	including a statement on any form promulgated by Federal
8	or State agencies; or

13	paragraph shall be a felony of the second degree punishable
14	by a mandatory minimum sentence of imprisonment of five
