Amending Title 18 (Crimes and Offenses) of the Pennsylvania Consolidated Statutes, in falsification and intimidation, 2 further providing for the offense of unsworn falsification to 3 authorities; and, in firearms and other dangerous articles, further providing for persons not to possess, use, 4 5 manufacture, control, sell or transfer firearms, for licenses 6 and for sale or transfer of firearms. 7 8 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: Section 1. Section 4904(b) of Title 18 of the Pennsylvania 10 Consolidated Statutes is amended to read: 11 12 § 4904. Unsworn falsification to authorities. * * * 1.3 (b) Statements "under penalty".--[A] 14 15 (1) Except as provided in paragraph (2), a person 16 commits a misdemeanor of the third degree if he makes a 17 written false statement which he does not believe to be true, 18 on or pursuant to a form bearing notice, authorized by law, to the effect that false statements made therein are 19 20 punishable. (2) A person commits a felony of the third degree if he 21

- 29 Act, or any equivalent Federal statute or equivalent statute

- 19 (c). A second or subsequent conviction for a violation of this
- 20 subsection shall be a felony of the second degree punishable by
- 21 a mandatory minimum sentence of imprisonment of five years.

- 29 (4) Any person, purchaser or transferee commits a felony
- of the third degree if, in connection with the purchase,

- 1 delivery or transfer of a firearm under this chapter, he 2 knowingly and intentionally: 3 makes any materially false oral statement; (ii) makes any materially false written statement, 4 5 including a statement on any form promulgated by Federal or State agencies; or 6 (iii) willfully furnishes or exhibits any false 7 identification intended or likely to deceive the seller, 8 9 licensed dealer or licensed manufacturer. A second or subsequent conviction for a violation of this 10 paragraph shall be a felony of the second degree punishable 11 by a mandatory minimum sentence of imprisonment of five 12
- 13 <u>years.</u>
