3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Protecting Volunteer
5 Firefighters and Emergency Responders Act”.

6 **SEC. 2. EMERGENCY SERVICES VOLUNTEERS.**

7 (a) **IN GENERAL.**—Section 4980H(c) of the Internal
8 Revenue Code of 1986 is amended by redesignating para-
9 graphs (5), (6), and (7) as paragraphs (6), (7), and (8),
10 respectively, and by inserting after paragraph (4) the fol-
11 lowing new paragraph:
